Saloni for strict compliance with ECI guidelines for vote counting

UDHAMPUR: District Election Officer (DEO) Udhampur, Saloni Rai, emphasized the need for strict compliance with the guidelines set forth by the Election Commission of India (ECI) to ensure a transparent and smooth counting process.

DEO Saloni Rai on Friday convened a meeting to review the arrangements for the upcoming vote counting scheduled on 8 October 2024 for the Assembly Elections 2024.

Additional Deputy Commissioner Prem Singh, Probationer Swati Sheemar, Additional Superintendent of Police Sandeep Bhat, all Returning Officers and senior officers of the district administration were present in the meeting.

A detailed discussion was held on various aspects of the counting process. These included ensuring uninterrupted power supply, seating arrangements for counting agents, maintaining the secrecy of the ballots, provision of adequate drinking water and upholding discipline and decorum at the counting center, law and order, security arrangements, counting of postal ballots, videography/CCTV during the counting process and arrangements for pre-counting of the ETPBS and VVPAT slip counting were also thoroughly reviewed.

She highlighted the importance of establishing separate entry points for candidates and counting staff to prevent confusion or overcrowding at the

A dedicated room equipped with communication facilities will be arranged for General Observers, aiding them in carrying out their responsibilities efficiently. Additionally, an LCD screen will be installed to provide real-time election results during the counting process.

The DEO further directed that law and order be strictly monitored throughout the counting period to avert any potential incidents. To enhance security and regulate the movement of people, a pedestrian zone will be established within 100 meters of the counting center. The DEO also mandated a three-tier security arrangement around the counting centers, which will include barricading of access routes and strict entry protocols to ensure the safety and integrity of the proceedings.

Rs 75000 fine imposed on garment manufacturer for deceptive labelling

JAMMU: Acting swiftly on a consumer complaint, the Legal Metrology Department Jammu has taken action against a Haryana based apparel manufacturing company, for violations of the Legal Metrology Act, 2009, and the Legal Metrology (Packaged Commodities) Rules, 2011.

During inspection at a prominent garment retail store at Apsara Road, Gandhi Nagar Jammu, a team of Legal Metrology officers/officials from the office of Deputy Controller Consumer Protection, Jammu, led by Jaideep Singh Sambyal, detected misleading practices involving neckties marketed under the brand "ALVARO CASTAG-

The product was prominently displayed as an imported item, alluring unsuspecting shoppers. However, during scrutiny of the product, it was revealed that the firm, based in India, had falsely presented itself as both the importer and manufacturer of the

It appears that the brand name was intentionally chosen to sound catchy and appear foreign to attract custom-

Responding to the show-cause notice issued by the Deputy Controller (Consumer Protection) Jammu, the company confessed to its labelling offences and sought departmental compounding—a legal remedy under the Act. Consequently, the company paid a composition sum of Rs. 75,000, assuring compliance with the packaging requirements as mandated under the Legal Metrology (Packaged Commodities) Rules, 2011.

In a hand-out issued by the Deputy Controller, Legal Metrology Department (Consumer Protection), Jammu, emphasized the importance of accurate product information on pre-packaged commodities to protect consumers rights from deceptive practice.

As per the Legal Metrology (Packaged Commodities) Rules, 2011, the manufacturers, packers, importers, suppliers, and sellers shall ensure that consumers must receive a set of accurate information about the pre-packaged commodities they purchase such as the address of the manufacturer/ packer/importer; the name of the country of the origin in case of imported products; the common or generic name of commodity, MRP, Net Quantity, Unit Sale Price (USP), customer care details (name, address, contact no, email of a person or office), etc., thereby avoiding instances of deception, cheating and fraudulent practices adopted by erring the traders.

Returning Officer issues notice on appointment of counting agents

SAMBA: The Returning Officer for AC 70-Samba, Kusum Chib issued an important notice to all candidates concerning the appointment of counting agents and the procedures to be adhered to during the upcoming vote counting on 8th October 2024

The notice emphasizes the critical steps for appointing counting agents who will oversee the counting of votes through Electronic Voting Machines (EVMs), Voter Verifiable Paper Audit Trails (VVPATs), and postal ballots. Candidates are reminded that they may appoint a maximum of 22 counting agents. The appointments must be made using Form 18, duly signed by either the candidate or their election agent, and must be submitted no later than 5:00 PM on 4th October 2024. Informal requests for agent appointments will not be entertained. In a meeting held today, Chib briefed all candidates regarding the notice, clarifying that on the day of counting, agents will be required to present their photo ID cards, issued by the Returning Officer, along with the second copy of Form 18 to gain access to the counting hall. Election agents must also carry their appointment letters.

Additionally, the Returning Officer highlighted that the appointment of counting agents can be revoked before the commencement of counting by submitting Form 19, and new agents can be appointed thereafter using Form 18.

Returning Officer urged all candidates to follow the outlined procedures meticulously to ensure a smooth and transparent counting process.
