

Forest Minister, CM’s Advisor assure govt support for CCIK’s tourism, eco, service push

SRINAGAR: The Chamber of Commerce and Industries Kashmir (CCIK) today held its executive meeting in Srinagar.

Minister for Forest, Ecology & Environment and Tribal Affairs, Javed Ahmed Rana and Advisor to the Chief Minister, Nasir Aslam Wani attended the meeting.

The meeting focused on strengthening Kashmir’s tourism ecosystem, protecting fragile environmental assets and improving the public utilities essential for sustainable development.

The CCIK presented key issues impacting the tourism and hospitality sector including provision of timber for houseboat repairs, a long standing demand

crucial for preserving Kashmir’s heritage tourism.

The Chamber emphasised the need to diversify Kashmir’s tourism offerings through ecotourism, adventure tourism and development of eco-friendly resorts and luxury camping facilities in forest zones. It urged the government to streamline the single-window clearance system for Pollution Control Committee approvals.

The CCIK highlighted that the existing multi-tiered approval processes have become a major bottleneck in execution of tourism, hospitality and infrastructure projects. It observed that a simplified and time-bound mechanism would significantly improve the compliance and enhance the investment climate.



Addressing the public utility challenges, the CCIK drew attention to the irregular water supply faced by the hoteliers in Pahalgam, compounded by limited tanker services. They appealed the Jal Shakti Minister to intervene and ensure reliable water availability across key tourist destinations, particularly during peak seasons.

Environmental conservation dominated the discussions, with CCIK expressing serious concern over the deteriorating condition of Dal, Nigeen, Wular, Anchar and other wetlands.

The Chamber called for a comprehensive cleanup drive and strict, encroachment-free protection measures, while requesting formal inclusion in all government-led consultations on water resource management. The Chamber demanded immediate restoration and long term conservation action on the worsening state of Babadamb Lake.

To enhance Kashmir’s tourism appeal, the CCIK proposed branding the region as a premier wedding destination, leveraging its natural beauty and cultural heritage. The Chamber also sought a review of entry fee structures at Aru and other tourist sites to ensure that pricing remains competitive and visitor-friendly.

GMC Srinagar Keeps Diagnostic Services Functional; MRI Unit Undergoes Essential Maintenance

SRINAGAR: The Government Medical College (GMC) Srinagar and its associated hospitals (SMHS/SSH) and other partner facilities have successfully maintained uninterrupted diagnostic services over the past two days despite the scheduled shutdown of the MRI unit at Shireen Bagh.

During the 48 hour period, a total of 67 MRI scans and 220 CT scans were completed across the network, ensuring that patients who required imaging continued to receive care without delay. The MRI at Shireen Bagh was taken offline on 4 December 2025 for an urgent de icing and repair procedure. A routine inspection had revealed ice buildup in the magnet’s venting system, which could have led to a helium leak and posed a safety risk to patients and staff.

MLA Lolab reviews Winter preparedness, progress on infrastructure Projects

KUPWARA: Member of Legislative Assembly (MLA) Lolab, Qaysar Jamshaid Lone, today chaired a crucial review-cum-preparatory meeting with senior officials from the Power Development Department (PDD) and the Jal Shakti Department to evaluate the status of ongoing infrastructure projects and finalize the strategy for winter preparedness across the constituency.

With the approaching harsh winter season, the MLA underscored the paramount importance of ensuring uninterrupted and reliable delivery of essential services, specifically power and drinking water, to the residents of Lolab. He directed all concerned departments to ensure complete logistical and infrastructural readiness on the ground.

The MLA released Rs. 50 lakh out of his CDF for improvement and augmentation of Power infrastructure in lolab constituency.

On the occasion, various vendors raised their issues before the chair about pendencies from different bank branches in disbursement of the loan applications. The DC directed the Lead District Manager and cluster head to ensure clearing of all pending cases within a weeks’ time positively.

Power Shutdown by KPDC

SRINAGAR: According to the Chief Engineer, Distribution KPDC, power shutdown of 33 kV Nihalpora-Pattan line will be observed due to which power supply to Pattan, Zangam, Hanjiwera, Buran, Hospital, Wanigam, Hyderbeigh and adjoining areas will be affected from 09.30 AM to 03.30 PM on 06 & 11 December, 2025.

Similarly, shutdown of 33 kV Pahalan Hamray tap line will be observed due to which power supply to Palhallan, Hamray, Wanigam, Hyderbeigh and adjoining areas will be affected from 09.30 AM to 03.30 PM on 08 December, 2015.

Likewise, shutdown of 33 kV Nihalpora-Gulmarg lineTangmarg, Gulmarg, Kulhama, Base Station, Baba Reshi Shrine, Mulgam, Khyber and adjoining areas will be affected from 09.30 AM to 03.30 PM on 10 and 13 December 2025.

Similarly, shutdown of 132 KV Mirbazar-Mattan Transmission line will be observed due to which power supply to Pahalgam, Achabal, Mattan, Gopalpora and adjoining areas will be affected from 09.00 AM to 03.30 PM on 08 December 2025.

National Lok Adalat to be Held Across Bandipora on December 13

SRINAGAR: District Legal Services Authority (DLSA) Bandipora, under the guidance of the Chairman, J&K Legal Services Authority, has informed that the next National Lok Adalat will be conducted across the district on December 13, 2025 (Saturday).

The National Lok Adalat is a vital public initiative aimed at ensuring speedy, amicable, and affordable dispute resolution, enabling citizens to settle their cases without prolonged litigation.

To ensure ease of access to justice for people from all areas of the district, multiple Lok Adalat benches will be set up. The benches will function in all courts operating from the District Court Complex, Bandipora, covering matters pending before the Principal District & Sessions Judge, Bandipora, Additional District Judge (Special Judge NIA), Bandipora, Chief Judicial Magistrate/Sub-Judge, Bandipora, Judicial Magistrate/Munsiff, Bandipora and

Additional Special Mobile Magistrate, Bandipora. Additionally, dedicated benches will also operate at the Court of Munsiff/Judicial Magistrate, Sumbal and Munsiff/Judicial Magistrate, Gurez to facilitate litigants from far-flung areas and reduce travel inconvenience.

The National Lok Adalat will take up a wide range of pre-litigation and pending cases, including Motor Accident Claims, Cheque Bounce Cases (NI Act Section 138), Criminal Compoundable Offences, Family and Matrimonial Disputes, Bank Recovery and Loan Settlement Cases, Public Utility Service Matters (electricity, water, etc.), Civil Disputes and Money Recovery Cases andTraffic Challans (Compoundable).

All litigants falling under these categories are urged to participate and utilize the opportunity for early settlement of their matters.

DLSA Bandipora has appealed to litigants, advocates, bank and insurance representatives, and the general public to approach the Office of DLSA Bandipora or the court staff at the District Court Complex Bandipora, Sumbal, and Gurez at the earliest, so that their matters can be identified, processed, and listed for hearing well in time.
