SC grants bail to TMC leader Kuntal Ghosh in cash-for-jobs recruitment scam case

NEW DELHI: The Supreme Court on Friday granted bail to TMC leader Kuntal Ghosh, who has been in judicial custody, in connection with the cashfor-jobs recruitment scam case registered by the CBI.

A bench comprising Justice Surya Kant and Justice Ujjal Bhuyan granted the bail considering the unlikelihood of the trial completing soon.

The Court said, "The petition is allowed and petitioner is directed to be released on bail, subject to conditions to be imposed by Trial Court." The Court also directed that Ghosh can't hold any public office for now.

Ghosh's counsel said that in July 2024, the investigation was still underway...trial court observed this in July... the investigation is not complete even to the extent that charges can be framed...Custody of over 19 months. 3 co-accused were granted bail.

CBI counsel alleged that Ghosh created a parallel

Justice Kant said, "Last time you said you (CBI) propose to examine 183 witnesses. Your investigation is not complete. We



don't want to impede your investigation, but the fact remains that process is taking further time. One can foresee process will take good amount of years... that's a practical approach,

CBI's allegations against Gosh are that he is a prominent leader of a political party which is presently

ruling the state. Under a deep-rooted conspiracy, the petitioner is alleged to have created a fake website resembling the original website where false results regarding the recruitment of primary teachers were

displayed. The petitioner is alleged to have collected bribes from undeserving candidates...one of his co-accused alone collected over 4 crore from 141 candidates and diverted to petitioner.

The petitioner was arrested on February 20, 2023, and has been in custody since then. He was acCalcutta High Court has

granted bail in the aforesaid ED case, adverting to the subject case registered The Court noted, "It ap-

pears that a chargesheet was filed on January 16, 2024. The said chargesheet revealed that no documents were appended.

Consequently, the special judge directed the investigating agency to submit all relied-upon documents, so that the court could consider cognizance.

On July 23, 2024, the court observed investiga-

tion was still underway and it was thus not conceivable for that court to commence trial and charges could not be framed.

The Court noted that the Additional Solicitor General (for CBI) has submitted that owing to the nature of the allegations, CBI is required to examine the plethora of documents and 100s of candidates, who are alleged victims of the alleged scam.

Supplementary charge sheet(s) will be filed, the court noted.

The Court said It is true that owing to the nature of the allegations and the nature of the evidence required to be collected, it is natural that the agency is likely to take some more time to file the final supplementary chargesheet.

It's too early to foresee the conclusion of the trial in the near future...Detention of petitioner in custody for an indefinite period will not be in conformity with well-settled principles of criminal jurisprudence.

The court said that a balance can be struck by restoring conditional liberty to the petitioner, in such a manner that he does not impede investigation.

Eight dead, 30 injured after bus overturns in Maharashtra's Gondia

MUMBAI: At least eight people died after a Maharashtra State Transport bus overturned near Bindravana Tola village on the Gondia-Arjuni road in the Gondia district on Friday afternoon.

The bus was on its way from Nagpur to Gondia.

"A State transport bus met with an accident in Gondia district. The bus was en route from the Bhandara depot to Gondia when the bus driver lost control of the vehicle near Bindravana Tola village on the Gondia-Arjuni road and overturned on the side of the road. Eight people have died and around 30 people are injured," said the police.

The official further said that the injured have been shifted to the Gondia District Hospital, adding that the death toll is expected to increase. According to information from the Chief Minister's Office (CMO), Chief Minister Eknath Shinde has ordered the Transport Administration to provide immediate assistance of Rs 10 lakh to the victims. "A State transport Shivshahi bus overturned



in a horrific accident. Eight bodies have been recovered from the site of the incident, and the death toll is expected to increase. Information about the situation was taken from the local administration. Instructions have been issued for immediate and proper treatment of the injured," said the CMO.

Deputy Chief Minister Devendra Fadnavis offered his condolences to the bereaved family members.

Taking to his official handle on X, Fadnavis posted, "It is very unfortunate that a Shivshahi bus met with an unfortunate

accident near Sadak Arjun in Gondia district in which some passengers died. I pay my heartfelt respects to the deceased. We share the grief of their families."

"The people who were injured in this incident may immediately receive treatment in a private hospital if necessary. I have also told the Collector of Gondia to make arrangements to shift them to Nagpur if required. Senior administration officials have reached the spot and are coordinating relief efforts. I pray to God for the speedy recovery of the injured in this incident," posted Fadnavis on X.

SC to decide whether advocates can work as Journalists, next hearing on Dec 16

NEW DELHI: The Supreme Court on Friday said that it will decide whether advocates can simultaneously work as journalists while practising law. A bench of Justice

Abhay S Oka and Justice Augustine George Masih was hearing a petition filed by Advocate Mohd. Kamran, who worked as a freelance journalist.

Justice Oka observed, "It was argued before us that it is permissible for a member of the bar to continue as a journalist. So we will decide that issue."

The Court had earlier directed the Bar Council of India (BCI) and the Bar Council of Uttar Pradesh to examine Kamran's dual roles and his compliance with the BCI Rules on Professional Conduct and Etiquette, which prohibit advocates from engaging in other professions or busi-

During Friday's proceedings, the counsel for the BCI sought two weeks to file an affidavit addressing the issue. The Court noted that Kamran has since filed an affidavit stating he will work only as an advocate. Taking his affidavit on record, the bench listed the matter for a hearing on December 16, 2024. The controversy dates back to July 2024, when

the Court questioned Kamran's dual roles, citing Chapter II of the BCI Rules. which bars advocates from engaging in business or full-time salaried employment. Kamran, however, defended his position, referring to Section 51 of the same chapter, which allows advocates to engage in journalism, teaching, or lecturing, provided these activities do not involve advertising or full-time employment.

He clarified that he was not salaried or employed by any media organization but merely contributed articles. The case originated from a defamation complaint filed by Kamran

against former BJP MP Brij Bhushan Sharan Singh. Kamran alleged that Singh wrote defamatory letters to Uttar Pradesh Chief Minister Yogi Adityanath, accusing him of having serious criminal cases while being a state-accredited journalist. The Allahabad High Court had quashed the defamation case, citing the confidential nature of the letters and the absence of

public dissemination. Kamran challenged the High Court's order in the Supreme Court, which, on July 29, 2024, directed the BCI and the Uttar Pradesh Bar Council to investigate his professional conduct. Notices were also issued in Kamran's petition challenging the High Court's dismissal of his defamation complaint. The upcoming hearing

on December 16 will address whether Kamran's dual roles align with the ethical and professional standards set by the BCI

BENGALURU: In a development that could spell fresh trouble for B S Yediyurappa, the state cabinet on Thursday decided to seek the governor's nod for the prosecution of the BJP veteran and former chief minister in an alleged Rs 12 crore bribery case over a Bangalore Development Authority (BDA) housing project in 2020. The cabinet concluded

that the governor [Thawaar Chand Gehlot] did not apply his mind while rejecting the petition seeking prosecution sanction against Yediyurappa. A decision was taken to advise the governor to reconsider his stance and grant sanction to investigate the corruption charges against Yediyurappa," H K Patil, the minister for law and parliamentary affairs, said after the cabinet meeting.

by Patil says: "It has been alleged that Accused No. 7 demanded a bribe of Rs 12 crore (on behalf of Accused No. 1 -- Sri B S Yediyurappa) from Accused No. 5 (Ramalingam Construction Company)."

The cabinet note further details: "The money was collected by accused No. 7, G C Prakash, from accused No. 8, K Ravi, for it to be delivered to accused No. 2, B Y Vijayendra [Yediyurappa's

The Rs 12 crore bribe charge was reportedly corroborated by an audio clip of an alleged conversation between Vijayendra and a private Kannada news channel.

"Prakash, the then BDA commissioner, demanded a Rs 12 crore bribe on behalf of Yediyurappa from Ramalingam company,' Patil added.

Following the revelations, T J Abraham, the president of Karnataka Anti-Graft and Environmental Forum, approached Governor Gehlot on Nov 11, 2020, seeking his sanction for Yediyurappa's prosecution. However, the governor

did not act on the petition for several months, leading Abraham to take the matter to the city civil and sessions court. In June 2021, the court dismissed it on grounds of insufficient sanction, after the governor junked the peti-

Interestingly, Abraham had earlier succeeded in obtaining prosecution sanction against chief minister Siddaramaiah in the Muda land allotment case -- a decision later upheld by Karnataka high

Eknath Shinde heads to native village after arriving from Delhi

Shinde, who returned to Mumbai from New Delhi on Friday morning is traveling to his native village in Satara district amid ongoing suspense over his successor, a week after the Maharashtra assembly poll results.

Shinde had told reporters in New Delhi late Thursday night that the next meeting of the Mahayuti alliance on government formation would be held in Mumbai on Friday.

However, the caretaker CM is now traveling to his native village Dare in Satara district in western Maharashtra, with the meeting now expected to take place on Sunday, according to sources.

The Shiv Sena leader has repeatedly stated that he would not be an obstacle in government formation and would abide by the decisions taken by Prime Minister Narendra Modi and Union home minister Amit Shah regarding the next



Different viewpoints are emerging within the Shiv Sena regarding Shinde's role in the next government, which will be headed by the BJP, the largest constituent in the Mahayuti alliance that achieved a resounding victory in the recently concluded assembly elections.

India, UK ink framework pact for development of electric propulsion systems for warships

NEW DELHI: India and the UK have sealed a framework agreement to co-design and co-produce electric propulsion systems to be used in futuristic warships in sync with their aim to broad-base cooperation in the strategic domain. A Statement of Intent (SoI) was inked for the proposed plan by the defence ministries of the two countries in Portsmouth on Thursday, an Indian readout of the development said.

The SoI would serve as a broader framework intended for cooperation in the co-design, co-creation and co-production of electric propulsion capability for future naval ships, it said. "The landing platform docks,

planned to be built at an Indian shipyard, are envisaged to have a full electric propulsion system," the readout issued by the defence ministry on Friday said.

"The signing was part of the third joint working group meeting of electric propulsion capability partnership, symbolising the commitment to promote indigenous development of niche technologies," it said.

From the Indian side, the SoI was signed by Joint Secretary (naval systems) Rajeev Prakash. Director of Ships Operations and Capability Integration in the UK's defence ministry Rear Admiral Steve McCarthy inked it from the British side.

Air India pilot suicide: Mumbai Police probe Aditya Pundit's deleted WhatsApp chats and video calls

MUMBAI: The Andheri Court on Friday extended the police custody of Delhi resident Aditya Pandit (27) until Monday.

Pandit was arrested by the Powai police in connection with the abetment of suicide case of Air India pilot Srishti Tuli (25), who was found dead at her rented house near Marol Police Quarters in Mumbai on November 25.

The police sought an extension of Pandit's custody to gather more evidence and retrieve deleted WhatsApp chats between him and Srishti from his mobile phone. Investigators believe the chats may provide crucial insights into the events leading to her death.

According to the Powai police, Tuli had made a video call to Pandit shortly before taking her own life. Authorities said she

died following an argument with Pandit.

His police custody, which began four days ago, was extended based on his alleged failure to report Tuli's threats and his decision to enter her locked house without involving law enforcement.

"Pandit's arrest stems from his failure to alert the

person in contact with the deceased has raised suspicion about his potential involvement," the police Before Pandit left for

Police are sceptical of his explanation and are working with forensic experts to recover the deleted content," a police officer

The remarks come even as the Bangladesh Financial Intelligence Unit (BFIU) has ordered the freezing of bank accounts belonging to 17 individuals associated with the ISKCON Bangladesh, including its former leader Chinmoy Krishna Das Brahmachari, for 30 days.

The directive, issued on Thursday, was sent to various banks and financial institutions in the country. It suspends all transactions from the accounts for one month.

This action follows the arrest of Chinmoy, spokesperson for the Sanatan Jagaran Jote.

On October 25, following a rally at Laldighi ground in Chittagong, he and 19 others were accused of sedition for disrespecting allegedly Bangladesh's national flag by hoisting a saffron flag above it, leading to a case filed at Kotwali police station on October 30.

The case was filed by local BNP leader Firoz Khan, who was later expelled from the party over the matter.

Chinmoy was arrested at Hazrat Shahjalal International Airport in Dhaka on Monday.

The following day, he was presented before a Chittagong court, where his bail plea was rejected, and he was sent to jail.

Supporters of Chinmoy protested his arrest. blocking the prison van for about two and a half Police eventually dis-
