marks on Friday at the Presidential Secretariat during the 2026 pre-budget discussion with private sector representatives from the agriculture, food and beverage sectors, according to the department.

The meeting focused on providing facilities for farmers, ex-

held on ensuring a continuous supply of quality agricultural and food products to consumers, as well as the challenges faced by businesses, with participants sharing their views and propos-

Dissanayake further explained that the government is focusing on securing full private sector support to expand markets for agricultural produce, dairy, and livestock.

While value addition is the responsibility of entrepreneurs, he said the government intends to introduce a new framework to facilitate the process.

#### 15 oil refineries operate in Afghanistan

KABUL: A total of 15 oil refineries are operational in Afghanistan, processing domestically extracted crude oil and low-quality imported fuel in the country, according to the private media outlet Tolonews on

### One dead, 57 injured in Sri Lanka bus crash

**COLOMBO:** One person was killed, with about 57 others being injured when a bus carrying pilgrims crashed in Pottuvil, in Sri Lanka's Eastern Province on Saturday, the police said. According to the police, the bus veered off the road

and struck a culvert before coming to a stop. The victim was identified as a 74-year-old man. The injured passengers were rushed to regional

hospitals for treatment, authorities said. Sri Lanka records frequent road accidents involving

buses. Police data showed that in 2024, the country recorded 2,541 deaths from 2,403 fatal road accidents.

# Russia makes massive raids on Ukraine's military sites

MOSCOW: Russia said Saturday that it conducted a massive overnight strike on Ukraine's military enterprises and airbases.

"The targets of the strike were achieved, and all designated objectives were hit," Russia's defense ministry said in a statement, adding that the raids involved high-precision weapons fired from land, air

On the same day, Kiev said Russia launched 537 drones and 45 missiles targeting seven locations overnight, with 510 drones and 38 missiles inter-

## **Ex-Ukrainian National Security Council** head Parubiy wanted in Russia since 2023

MOSCOW: Former Secretary of Ukraine's National Security and Defense Council, Andriy Parubiy, who was shot dead in Lvov (also known as Lviv) on Saturday, had been listed as a wanted criminal by the Russian Interior Ministry since 2023, police records

Earlier in the day, Ukrainian police reported the killing of "a well-known public and political figure born in 1971" in Lvov. Ukrainian President Volodymyr Zelenskyy confirmed Parubiy's death. A Ukrainian newspaper, Strana.ua, reported that he was shot dead in the street by a man posing as a

According to Russian police data, Parubiy has been wanted by the Interior Ministry since November 2023. The Russian Investigative Committee charged Parubiy in absentia for atrocities committed in Donbas in 2014, which left 1,200 people dead or injured.

In April, a member of the Ukrainian Stop Grave resistance group told Sputnik that an investigation into a deadly fire at the Trade Unions House in Odesa, which killed 48 people and injured more than 250 others on May 2, 2014, was obstructed by a group of journalists established by then-National Security and Defense Council chief Parubiy.

## Trump talking to European allies about sending US contractors to Ukraine - Reports

**WASHINGTON:** President Donald Trump is negotiating with European allies the deployment of private US military companies to Ukraine as part of a long-term peace plan, The Telegraph newspaper reported on Saturday, citing

The proposal is a workaround to Trump's pledge not to send US troops to Ukraine. Private military companies could help reinforce Ukraine's defenses, establish new bases and protect US businesses, the UK daily reported.

On August 18, Trump held a meeting in Washington with Ukrainian President Volodymyr Zelenskyy and EU leaders, after which he announced that France, Germany and the United Kingdom wanted to deploy troops on Ukrainian territory. He added that there



would be no US troops in Ukraine during his presi-

# Palestinian President Mahmoud Abbas barred from attending UNGA session as US revokes visa

NEW YORK: Palestinian President Mahmoud Abbas has been barred from attending the UN General Assembly session in New York next month, following the US revoking his visa and that of 80 other Palestinian officials.

Secretary of State Marco Rubio has accused the Palestinians of undermining global efforts for peace, due to their insistence on seeking "the unilateral recognition of a conjectural Palestinian state", reports Financial Times.

The cancellation of their visas was welcomed by Israel, with the country's Foreign Minister Gideon Saar expressing his gratitude to Rubio.

In a post on X, Saar wrote "Thank you @SecRubio for holding the "PLO" and PA accountable for rewarding terrorism, incitement and efforts to use legal warfare against Israel.

'We thank @POTUS and the Administration for this bold step and for standing by Israel once again.

Washington's ban comes in the wake of a planned initiative where several countries such as France and Canada have opted to recognise a Palestinian state during the annual global

Explaining the move, the State De-



partment announcement said, "It is in our national security interests to hold the Palestine Liberation Organisation and the Palestinian Authority accountable for not complying with their commitments, and for undermining the prospects for peace.

Abbass expressed disappointment over the US move, and said that the State Department's decision was in contradiction of international law.

'The American State Department's

decision contradicts international law. The American administration must reverse its decision and allow the Palestinian delegation's entry." Rubio said the department would

allow exemptions for the Palestinian delegation to the UNGA, as required by the UN headquarters agreements of 1947. But a department spokesperson said this would not apply to Abbas, who as president of the Palestinian Authority typically attends the annual meeting.

The Trump administration has rejected any possibility of granting statehood to Palestine, with Rubio accusing PLO and the Palestinian Authority of indulging in terrorism and engaging in war crimes.

He also blamed the absence of a ceasefire in Gaza on Palestinian appeals to the International Criminal Court and International Court of Jus-

"The PA must also end its attempts to bypass negotiations through international lawfare campaigns, including appeals to the ICC and ICJ and efforts to secure the unilateral recognition of a conjectural Palestinian state," Rubio
