Matuas met Rahul Gandhi in Bihar, sought support from Cong on citizenship demand: Adhir

KOLKATA: A delegation of the politically significant Matua community of West Bengal met Congress leader Rahul Gandhi in Bihar last week, and sought the party's support for their long-standing demand for citizenship, senior leader Adhir Chowdhury said on Wednesday.

Gandhi, who was leading the 'Voter Adhikar Yatra' in the neighbouring state, asked them to come to Delhi. where a detailed discussion on the issue could be held, Chowdhury told PTI. Matuas, originally from East Pakistan, are a weaker section of Hindus who migrated to India during the Partition and after the creation of Bangladesh, following religious persecution. The SC community holds sway over several constituencies in the state, where assembly elections are due next year. Both TMC and BJP have lawmakers from the Matua group.

"Rahul ji met the delegation from the Matua community on Saturday at Ekma in Saran district of Bihar and listened to their problems for some time. He told them to come to Delhi, where he would listen to them elaborately on their demand for citizenship and possibly throw some light on what could be their next course of action," Chowdhury said.

Though the Matuas possess vot-



cards, the community members have been demanding "legal citizenship" as those documents do not suffice as proof of that.

The former state Congress president said that members of the group had met him in Murshidabad a few weeks ago when they expressed their interest in supporting the grand old party

"They believe that under Rahul ji's leadership, they would be able to get their dues, as they think that both TMC and BJP have used them for their political benefits. They were er cards, Aadhaar cards, and ration quite influenced by Rahulji's leader-

ship in the movement against the SIR of the electoral rolls. I advised them to go and meet Rahul ji during the yatra," Chowdhury said.

When contacted by PTI, TMC spokesperson Kunal Ghosh declined to make any statement on the meeting.

Senior BJP leader Rahul Sinha did not want to give any importance to the matter.

"Anyone from anywhere claiming to belong to the Matua community will not get any attention. This is a very insignificant thing to gain any attention," the former state BJP president

NEW DELHI: A Delhi court ticipatory bail plea, the IO hi Police is investigating the has granted interim protection from arrest to Bikram Gogoi, whose name surfaced in the abduction and attempted murder case against R&AW ex-officer Vikash Yadav.

ThePrint had reported about Gogoi applying for anticipatory bail after an investigating team sent him four notices and summoned him for questioning.

"In these circumstances, as the applicant/accused, is willing to join the investigation, hence, he is directed to join the investigation on 06.09.2025 at 2.00 p.m. before the IO (investigating officer). Fresh reply/ report be filed by the IO to the present bail application on 11.09.2025. Till then no coercive action be taken against the applicant/accused (sic)," the court said. The next date of hearing is 11 September.

In response to Gogoi's an-

stated that the Guwahati resident's name surfaced after co-accused Abudullah Khan, in his disclosure statement, said that he had come in contact with the other accused, Jalaluddin, through the 24-year-old.

Though Gogoi stated that he studied with Jalauddin alias Sameer (an accused in the abduction case) in a Delhi school and had introduced him to Khan, he claimed innocence in the abduction

The Special Cell of the Del-

abduction and attempted murder case lodged in 2023 against Yadav and others All three accused (Yadav, Khan and Jalaluddin) are currently out on bail.

Delhi businessman Raj Kumar Walia had accused Yaday and Khan of abducting and torturing him, while demanding ransom in the name of jailed gangster Lawrence Bishnoi. Subsequently, the charge sheet filed last year in the case says that it was Jalaluddin who allegedly gave Bishnoi the contract to kill Walia.

Yadav was arrested just weeks after the US Department of Justice indictment named him in the alleged murder-for-hire plot against Sikh separatist Gurpatwant Singh Pannun. While Yadav is wanted by the Federal Buawaits his trial in the US from a Brooklyn prison.

Cousins plan to destroy our family & BRS, says beleaguered **Kavitha after resigning from party**

HYDERABAD: Telangana Jagruthi leader and the Bharat Rashtra Samithi (BRS) chief K Chandrashekhar Rao's daughter K Kavitha on Wednesday lashed out at BRS leaders T. Harish Rao and J. Santosh Rao, accusing them of "planning to destroy our family and party" in connivance with Telangana Chief Minister Revanth Reddy. On Tuesday, BRS had sus-

pended Kavitha for "anti-party activities", a day after her outbursts against party leaders T. Harish Rao and J. Santosh Rao. The two leaders, relatives of K Chandrashekhar Rao, are considered close to the party chief. Harish Rao has been associated with the BRS since its inception.

Kavitha also said in today's press conference that she is resigning from BRS and submitting her MLC resignation letter to the Council Speaker. "Yesterday afternoon, I saw media reports about the BRS Party's suspension of me. After being released from Tihar jail, I participated in various programs and worked for BC Reservations and other initiatives against the Congress government while wearing the BRS flag. I don't understand how these actions constitute anti-party activities," Kavitha said.

"I'm requesting my father to examine the party leaders surrounding him. I spoke straightforwardly and requested him to consider my words. Revanth Reddy and Harish Rao planned to destroy our family while travelling together on a flight; Revanth Reddy should answer

for this," she said. "Revanth Reddy booked cases



against only my family members, KTR, and KCR, but not against Harish Rao, When the Kaleshwaram project began, Harish Rao was the Irrigation Minister, and Revath Reddy didn't speak out against him, she added.

She said that she had previously spoken with her brother and BRS Working President KT Rama Rao about people in the party plotting against her, and asked him to take action. "Harish Rao and Santosh Rao are planning to destroy our family and party. Harish Rao wasn't a troubleshooter but was a "bubble shooter." He gave money to work against KCR and KTR in the Assembly elections," she said.

On September 1, BRS MLC K Kavitha, while reacting to the Telangana government's decision to order a Central Bureau of Investigation (CBI) probe into the Kaleshwaram project, alleged that any taint on KCR's image regarding the Kaleshwaram issue is due to BRS leaders Harish Rao and Santosh Rao, accusing them of conspiring against her and

ed his five-day-old fast after the Maharashtra government accepted most of his demands, including granting eligible Marathas Kunbi caste certificates, which will allow them to avail of quota in education and jobs enjoyed by Other Backward Classes (OBCs). The activist called off his hunger strike in the presence of senior BJP minister Radhakrishna Vikhe Patil, who heads the cabinet sub-committee on Maratha reservation, and other members of the panel at south Mumbai's Azad Maidan, the site of his agitation since August 29. "Not a single line had been written by the state government in our favour till now. People should not believe in the 'joker-type' individuals (who have criticised his move). Those speaking against the decision have done nothing for the Maratha community," Jarange said.
