Singapore key partner in India's Act East Policy, vision for Indo-Pacific: President Murmu

NEW DELHI: Singapore is a key partner in India's Act East Policy and vision for Indo-Pacific region, President Droupadi Murmu said on Thursday while emphasising different aspects of the comprehensive strategic partnership between the two countries.

Murmu said Singapore is a major source of investments for India and Singaporean investments in the country are also growing.

She highlighted the expanding defence cooperation, which includes bilateral exercises and training.

Welcoming Singaporean Prime Minister Lawrence Wong, who called on the president at the Rashtrapati Bhawan here, Murmu also appreciated the important role played by the large Indian diaspora in Singapore, which has contributed immensely to fostering cultural and people-to-people exchanges between the two countries.

She said India and Singa-



pore are important partners for each other, and "Singapore is also a key partner in India's Act East Policy and vision for the Indo-Pacific". The president said 2025 is of special significance as it marks the 60th anniversary of the establishment of diplomatic relations between the two countries.

Singapore's President Tharman Shanmugaratnam visited India in January.

Six senior ministers, including Foreign Minister Vivian Balakrishnan, participated in the 3rd India-Singapore Ministerial Roundtable held in Delhi just a few weeks ago, according to a statement issued by the presiMurmu further highlight-

ed that the India-Singapore relationship was elevated to a comprehensive strategic partnership during Prime Minister Narendra Modi's visit to Singapore last year. The president was happy to note that Wong and Modi jointly laid out a roadmap for this partnership on Thursday, truly reflecting the depth and expanse of the bilateral cooperation. Murmu said the bilateral

agreements concluded on Thursday will boost the cooperation between the two countries in new and emerging sectors like green economy, space, civil aviation, fintech and skill development. Both leaders agreed that regular interactions at the highest political levels are a hallmark of the India-Singa-

Students to chant mantras, practise yoga as NDMC schools adopt 'Guru-Shishya' form of learning

NEW DELHI: Chanting mantras, practising yoga and meditating -- that is how students will begin their day in NDMC schools while teachers impart education following the classical Guru-Shishya model.

This is part of the 'Vikas Bhi, Virasat Bhi' curriculum launched by Delhi Chief Minister Rekha Gupta at the Talkatora Stadium here on Thursday, the eve of Teachers' Day. Fifteen teachers were felicitated at the event for their contribution to education.

The 'Vikas Bhi, Virasat Bhi' initiative seeks to integrate India's cultural heritage into modern education that would benefit more than 28,000 students across NDMC-run

According to the curriculum document, students will now recite Sanskrit mantras such as the Gayatri Mantra, Saraswati Vandana, Guru Mantra and Shanti Path during daily assemblies.

Each has a defined educational purpose -- the Gayatri Mantra to enhance concentration and clarity, Saraswati Vandana to cultivate intellectual focus, the Guru Mantra to instil respect for teachers, and the Shanti Path to encourage peace and harmony, according to the document. The curriculum notes that

chanting mantras fosters mindfulness, positivity and compassion, while teaching humility, discipline and ethical responsibility. It emphasises that education must nurture wisdom and values alongside academic knowl-

Another key feature is the

integration of yoga and meditation into the school timetable. Breathing practices like Anulom-Vilom and Bhramari are aimed at boosting lung capacity, immunity and mental focus. Postures including Tadasana, cat-cow stretch and 'Bhujangasana' will be taught to improve flexibility, posture and motor coordination. Mindful meditation techniques such as gratitude reflections, five-senses awareness and body scans are designed to help students regulate emoproved concentration, emotional balance, and overall well-being.

The programme also expands learning beyond classroom walls. Nature walks, outdoor science labs, gardening and eco-art projects like leaf printing and nature mandalas are included to connect students with biodiversity and environmental conservation. According to the document, arithmetic will be taught by counting leaves and measuring garden spaces, while science classes will involve observing plants,

birds and insects. Literature and art will draw inspiration from natural "Learning surroundings. beyond walls, wisdom beyond books" is described as a guiding principle of this approach. At its core, the curriculum revives the Guru-Shishya Parampara model, promoting respect for teachers and mentorship among peers.

A house system based on great gurus -- Dronacharya (discipline), Vyasa (wisdom), Charaka (health) and Vashishtha (righteousness) -- will instil values through collective activities.

The curriculum also highlights inclusivity, with buddy programmes pairing differently-abled and mainstream students, as well as intergen-

erational learning. Elderly citizens will be invited to share stories, skills and life lessons, while students will introduce them to modern tools and technologies. A 10-week Swachhta module

forms another pillar of the programme. Students will practise waste segregation, water conservation, and plastic reduction through hands-on activities such as clean classroom competitions, poster-making and plantation drives.

They will also be introduced to hygiene drills, food safety and eco-friendly alternatives like making cloth bags from old garments.

The "Vikas Bhi, Virasat Bhi" document underlines that the initiative is aligned with the National Education Policv 2020 and NCERT syllabus, while drawing inspiration from India's traditional

NEW DELHI: Delhi's power discoms are on high alert and working roundthe-clock to maintain power supply in the low-lying areas, officials said

Restoration is being prioritised strictly based on safety conditions and official clearance, while the discoms continue to work closely with civic authorities, the Flood Control department, and disaster management teams, they said.

With the Yamuna in spate, several low-lying localities along the river, such as Yamuna Bazaar Ghat, Chabi Ganj, Mori Gate, Badarpur Khadar Village, Nanaksar Gurdwara, Pakistani Refugee Camp, Usmanpur Khadar Village, and Garhi Mandu Khadar Village, have been flooded.

Assam CM lays foundation stone for community kitchen where meals for 25,000 children will be cooked

GUWAHATI: Assam Chief The CM recalled his visit to Minister Himanta Biswa the ISKCON temple in Ben-Sarma on Thursday laid the foundation stone of a community kitchen in Sonitpur district, where mid-day meals of 25,000 children will be cooked.

The new kitchen in Durrung Tea Estate will serve students of schools across the Tezpur, Rongapara and Barchala assembly constituen-

Sarma said the government will spend Rs 25 crore for the project, and ISKCON will also build a temple at

He said the funding for midday meals will be shared, with 60 per cent borne by the state government and 40 per cent by the Akshaya Patra Foundation.

Sarma said the implementation of the mid-day meal Scheme has greatly benefited students from poor families, and along with this, the state government has introduced free uniforms and free admission schemes, which together have created a healthy educational environment

The community kitchen, to be built over 1,718 sq metre, will have staff quarters, a training centre, a multipurpose hall and utility and security blocks.

Sarma said inspired by this, he initiated the first centralised kitchen in Jalukbari constituency that has been serving mid-day meals to 45,000 students and also to hospital attendants and patients for the last 12 years. He said that a centralised kitchen has already been set up in Jorhat, catering to 20,000 students, while another is nearing completion in Majuli.

Construction of such kitchens has also begun in Nalbari, Dibrugarh and Lakhimpur recently, he said.

Sarma said the government is considering providing breakfast for students in tea garden areas, as many parents leave early in the morning for work.

He announced that a new scheme will be launched in November, under which Rs 300 per month will be provided to every student appearing for the High School Leaving Certificate (HSLC) examination, until they pass. This will support 5 lakh students of the state, he said.

Reopening of NH-2 does not arise as it has never been closed: Kuki Zo Council

IMPHAL: The Kuki Zo Council (KZC) on Thursday asserted that the issue "reopening" National Highway-2 (Imphal-Dimapur) does not arise, as the road was never closed or blocked, and cautioned that its decision must not be misinterpreted as an endorsement of unrestricted or free movement across the Meitei and Kuki

In a press statement, KZC said, "We categorically reiterate that the Imphal-Dimapur NH-2 has never been closed or blocked. The NH-2 has consistently remained open for commuters and for the transportation of essential goods. Therefore, the question of 'reopening' does not arise, contrary to certain media reports," it

It added, "Our appeal was specifically confined to the stretch of NH-02 passing through Kangpokpi district. It must not be misinterpreted as an endorsement of unrestricted or free movement across the buffer zones. The sanctity of the buffer zones be-



tween the Meitei and Kuki-Zo areas will continue to be strictly respected and maintained.'

The council said its appeal was simply to urge the people of Kangpokpi to extend cooperation to the central security forces deployed to ensure safety along the highway.

"It is the responsibility of the Government of India to deploy and manage central forces to secure commuters and the transport of goods. It is neither the duty of the local public in Kangpokpi nor of KZC to guarantee foolproof security for national highway users. The MHA has assured that adequate central forces will be deployed to provide necessary security along NH-02 (Imphal-Dimapur)" it

Two prominent Kuki-Zo groups on Thursday signed a suspension of operations (SoO) agreement with the government on re-negotiated terms and conditions under which they agreed on maintaining territorial integrity of Manipur, relocating designated camps away from vulnerable areas and working for a solution to bring lasting peace and stability in the state. GST reforms to strengthen India's clean energy transition: Environment minister

NEW DELHI: Union Environment Minister Bhupender Yadav on Thursday described the government's overhaul of the Goods and Services Tax (GST) as a "historic Diwali gift" that will strengthen India's clean-energy

In a post on X, Yadav said, "The GST rationalisation ensures that renewable energy remains the backbone of India's climate strategy.

In another post, he termed the move "GST Reforms for a Green India" and said it would help advance clean and green power adoption, improve waste management, lower emissions and protect ecosystems, while maintaining fiscal balance.

A steady adoption of solar, wind and waste-to-energy projects is critical for meeting India's Net Zero 2070 pledge and Nationally Determined Contributions (NDCs) under the Paris Agreement, he added.

The reforms, announced on Wednesday, include tax cuts on solar panels, wind turbines and related devices to reduce project costs



and support domestic manufacturing, lower GST rates on effluent treatment services to boost centralised waste management and a steep reduction on biodegradable bags to help curb single-use plastics.

The GST on passenger buses and commercial goods vehicles has also been reduced from 28 per cent to 18 per cent, in a move partment. expected to cut costs, encourage fleet modernisation and promote public transport.

Ghosh said that he has learnt from sources that a civil defamation suit has been filed against him by Chakraborty before the high court for alleged comments made by the TMC leader. Chakraborty had earlier sent a legal notice to Ghosh, to which the TMC leader's lawyer Ayan Chakraborty said that he had already sent a reply.
