#### LG Gupta emphasizes ...

the Primary Health Centre (PHC), Thiksey.

The system has been developed jointly by Energy Efficiency Services Limited (EESL) and Alfen Alfa Group on a pilot basis to address the pressing challenge of heating requirements during Ladakh's extreme winters.

Highlighting the significance of the project, the Lt Governor said that if the pilot proves successful, the ecofriendly heating model could be scaled up across health centres, schools, and government institutions in Ladakh.

He noted that such sustainable solutions not only reduce the dependency on conventional fuels but also provide a cost-effective and reliable means to improve infrastructure in remote and high-altitude areas.

The Lt Governor reaffirmed the UT Administration's commitment to making Ladakh a carbon-neutral Union Territory and said that the adoption of clean technologies is integral to achieving this goal.

He stressed that initiatives like the geothermal heating project will play a crucial role in protecting the fragile ecology of the region while simultaneously improving public service delivery and healthcare infrastructure.

Getting back to UNGA development, the 80th session of the UN General Assembly will open on September 9. The high-level General Debate will run from September 23-29, with Brazil as the traditional first speaker of the session, followed by the US.

US President Donald Trump will address world leaders from the iconic UNGA podium on September 23, his first address to the UN session in his second term in the White House.

According to a revised provisional list of speakers for the high-level General Debate of the 80th session of the General Assembly released Friday, India will be represented by a 'minister'.

External Affairs Minister S Jaishankar will address the session on September 27.

According to a previous provisional list of speakers issued in July, Modi was scheduled to address the General Debate on September 26.

The heads of government of Israel, China, Pakistan and Bangladesh are scheduled to address the UNGA General Debate on September 26.

Modi had travelled to the US in February this year for a bilateral meeting with Trump at the White House in Washington. Trump has imposed tariffs totalling 50 per cent on India, including 25 per cent for Delhi's purchases of Russian oil.

The UNGA list of speakers for the General Debate is provisional and there is always possibility of changes in schedules and speakers ahead of the commencement of the high-level week.

The list will continue to be updated accordingly.

Considered the "busiest diplomatic season" of the year at the United Nations Headquarters, the high-level session opens in September annually.

The session this year comes amid the continued Israel-Hamas war as well as the Ukraine conflict. The theme for the 80th session is 'Better together: 80 years and more for peace, development and human rights'.

The session will open with a meeting to 'Commemorate the 80th Anniversary of the United Nations' on September 22.

Marking the 30th anniversary of the Fourth World Conference on Women, the UN General Assembly will convene a high-level meeting centred on the theme "Recommitting to, resourcing and accelerating the implementation of the Beijing Declaration and Platform for Action to achieve gender equality and the empowerment of women and girls".

The meeting will reflect on progress since the landmark 1995 conference in Beijing and highlight achievements, best practices, gaps, and ongoing challenges in advancing gender equality worldwide, the UN said.

UN Secretary-General Antonio Guterres will convene a Climate Summit on September 24 to serve as a platform for world leaders to present their new national climate action plans and seize the benefits of the new clean energy era.

Other high-level meetings to be held during the week include Summit for a Sustainable, Inclusive and Resilient Global Economy; Noncommunicable Diseases and Mental Health and Well-being; 30th Anniversary of the World Programme of Action for Youth; Launch of the Global Dialogue on AI Governance; International Day for the Total Elimination of Nuclear Weapons; and Situation of Rohingya Muslims and other minorities in Myanmar.

chair of the BRICS. The 10-member grouping also includes India, China, Russia, South Africa, Indonesia, Iran and the United Arab Emirates.

"The Brazilian chair of BRICS has called for a virtual meeting on September 8," External affairs ministry spokesperson Randhir Jaiswal said on Friday.

"From our side, it will be the external affairs minister who will be participating in (the meeting). This BRICS Summit is at the leaders' level," he said at his weekly media briefing.

Lula had dialled Prime Minister Narendra Modi on August 7 during which both the leaders pledged to strengthen bilateral trade and energy ties.

The US slapped 50 per cent tariffs on Brazilian exports like in the case of India.

The Brazilian president is likely to discuss the tariff issue at the BRICS virtual summit, according to reports from Brazil.

People familiar with the matter said New Delhi decided to nominate Jaishankar to attend the summit as part of "balancing act" with Washington getting increasingly suspicious about the agenda of BRICS.

US President nald Trump has made a series of comments cautioning BRICS against any "de-dollarisation" efforts.

BRICS, originally comprising Brazil, Russia, India, China, and South Africa, expanded in 2024 to include Egypt, Ethiopia, Iran, and the United Arab Emirates, with Indonesia joining in 2025.

It has emerged as an influential group representing around 49.5 per cent of the global population, around 40 per cent of the global GDP and around 26 per cent of the global trade.

organized a special programme in Kargil on the implementation of the three new criminal laws.

Quoting, 'Nip the evil in the bud,' the CEC called for joint efforts with the DC, SSP, and other officials to keep Kargil a crime-free district.

Akhoon also highlighted the role of religious scholars, who he said contributes to 90% to crime prevention, and encouraged feedback from students.

A special drama performance by the Police team explained the provisions of the new laws—Bharatiya Nyaya Sanhita (BNS), replacing the Indian Penal Code; Bharatiya Nagarik Suraksha Sanhita (BNSS), replacing the Code of Criminal Procedure; and Bharatiya Sakshya Adhiniyam (BSA), replacing the Indian Evidence Act.

The drama highlighted how these laws, effective from 1st July 2024, modernize the criminal justice system. Special focus was given to digital evidence, forensic support, speedy trial mechanisms, victim protection, and technology-driven investigation tools such as the e-Sakshya App, forensic kits, and video conferencing from jails.

As a doctor by profession, the CEC emphasized the importance of post-mortems in criminal justice and urged religious leaders to spread awareness in society.

Following his remarks, it was underlined that Ladakh UT is the first Union Territory to implement the new laws with advanced technology. This includes 443 CCTV cameras (some AI-enabled) for crime detection, BNSS provisions to inform families in case of arrest, E-prosecution and FSL facilities, and video conferencing from jails for speedy trials. The system also has provisions for first-time offenders, giving them an opportunity to reform within 90 days.

SSP Shree Raam in his address, highlighted the importance of digital evidence, fast-track processes, and proper collection of material from crime scenes. He stressed that the use of forensic tools and technology will ensure more effective justice delivery.

The vote of thanks was presented by Additional SP Nitin Yadav, who expressed gratitude to all dignitaries, participants, and students for their active participation.

"The administration is working to reduce these hurdles so that students, particularly girls, are not held back due to long travel, safety concerns, or financial constraints," he assured.

Stressing that inclusive growth must reach every village, the Lt Governor said citizen participation, combined with government initiatives in key sectors, would ensure equitable development across the Union Territory.

Meanwhile, the Lt Governor visited the Chumathang Hot Springs, famous for its therapeutic mineral-rich waters, which are believed to have medicinal properties, especially for skin ailments and joint pain.

She said the work at the Council was truly "remarkable".

Despite apprehensions over loss of revenue from classifying most products into categories: 5 per cent for common use goods and 18 per cent for everything else, and doing away with 12 and 28 per cent slabs, the GST Council took a unanimous decision for the GST rejig.

The panel was to meet for two days starting September 3 to discuss the proposal made by the Centre but ended up approving it on the very first day after a marathon daylong meeting.

'So the sense of the house was, this is a proposal which

is going to undoubtedly benefit the common man. There is no point in standing against it... Ultimately everybody came together for a good cause, and I'm truly very grateful," Sitharaman said.

The minister said states were always in favour of rate

reduction and their only concern was with regard to their revenue implications post-tax cuts.

"I even appealed to them, saying, for the sake of the people of India, Please. It's not just the states. It's even the Centre that is going to get affected by the reduction. But we'll make up for it because once the rates come down,

people are going to come out to buy, and that will take care of it (revenue impact). That's how consensus was arrived at," she said.
